BE IT RESOLVED by the School Board of the Green Bay Area Public School District, Brown County, Wisconsin that there shall be issued pursuant to Chapter 67 of the Wisconsin Statutes, general obligation bonds in an amount not to exceed \$69,000,000 for the public purpose of paying the cost of constructing and equipping a new high school facility; and expanding, remodeling, repairing, renovating, improving, and equipping District school facilities; acquiring school sites; and paying related costs.
